## Coronavirus Travel Policy of Air Tahiti Nui, The Americas

Dear Valued Partner of Air Tahiti Nui, The Americas:

In careful response to the global concerns regarding the Coronavirus outbreak in Asia, Air Tahiti Nui will comply with the below health order of the French Polynesian government on its flights to Pape'ete, French Polynesia.

## FOR THOSE CUSTOMERS HAVING NOT VISITED ASIA SINCE JANUARY 1<sup>ST</sup>, 2020:

You may travel to French Polynesia without any medical certificate. Please note that French Polynesia has not reported any cases of Coronavirus, nor does Air Tahiti Nui operate direct, non-stop service to mainland China from French Polynesia.

FOR THOSE CUSTOMERS HAVING VISITED OR TRANSITED THESE ASIAN COUNTRIES LISTED SINCE JANUARY 1<sup>ST</sup>, 2020: China, South Korea, Taiwan, Thailand, Vietnam, Philippines, Hong Kong, Japan, Macao, Singapore, India, Sri Lanka, Nepal, Malaysia, Cambodia

You must present a medical document affirming a state of good health, cleared of any viral infection, signed by a medical doctor, <u>no matter your gateway of embarkation</u>. This medical document must be dated a maximum of 5 days before travel on Air Tahiti Nui and requires presentation to Air Tahiti Nui staff upon check-in at the airport. Passenger failure to present such a document will result in denied boarding at the discretion of airport staff.

FOR THOSE CUSTOMERS HAVING VISITED OR TRANISTED THE AFOREMENTIONED ASIAN COUNTRIES SINCE JANUARY 1<sup>ST</sup>, 2020, WITH TRAVEL DEPARTING LOS ANGELES AIRPORT (LAX):

In the absence of a signed medical certificate, as an alternative, a nearby 24-Hour Urgent Care facility outside of LAX Airport may be able to provide a signed medical certificate. It is our understanding that most US insurances are accepted at this facility, otherwise a \$165.00 USD charge will be applicable for a consultation and clearance for a travel certificate. For customers electing to seek a certificate, allow at least 5 hours as this facility is not connected to LAX, or the Tom Bradley International Terminal.
